

Web3 Labs LLC Terms and Conditions

Please review these Terms of Use (“**Terms**”) carefully as they outline the legally binding terms and conditions that govern your access to and use of the web-hosted user interface provided by Web3 Labs LLC (“**Web3 Labs**,” “**we**,” “**us**,” or “**our**”) including related trademarks, software code, and intellectual property (the “**App**”). These Terms govern your rights, obligations, and our disclaimers and limitations of liability relating to the use of the App and associated services. By using the App, you agree to be bound by these Terms.

1. Description of the App

11.1. Your use of the App is subject to Web3 Labs' Privacy Policy, which outlines how we collect, use, and protect your personal data. By using the App, you consent to our processing of your data as outlined in the Privacy Policy.

12. Changes to the Terms

12.1. Web3 Labs may modify these Terms from time to time. Any changes will be effective upon posting, and continued use of the App after the posting of changes constitutes acceptance of the revised Terms.
